QUARTERBACK QUEST

Terms and Conditions

- The Quarterback Quest Promotion (the “**Promotion**”) will run from 00:00 EST on September 2, 2024 until 23:59 EST on September 15, 2024 (“**Promotion Period**”).
- To participate in the promotion, Operators must opt-in by completing the online opt-in form made available at <https://promo.evolution.com/quarterback-quest/> no later than August 15, 2024 in order to participate in the Promotion (“**Participating Operator**”).
- **Mechanics:** For each 20 USD wagered by a player on an Eligible Slot Game (defined below) during the Promotion Period, the player will receive 1 entry ticket to a prize draw, up to a maximum of 25 entry tickets per player, per day. Wager amounts shall be calculated daily to determine the number of tickets players receive for each day during the promotional period.
- Operator may not require any further action by the player to “opt in” to the Promotion besides wagering at least 20 USD on an Eligible Slot Game during the Promotion Period.

- Operator must clearly state the Eligible Slot games on the Operator site/s.
 - A minimum of 20 Eligible Slot Games must be displayed on Participating Operator's home page at all times during the Promotion Period to qualify for the prize draw.
 - The prize draw will be held on September 18, 2024.
 - Final results of the prize draw will be announced on September 18, 2024 15:00 EST.
 - 1000 winning players will be selected based on the prize draw. Only players from New Jersey, Pennsylvania, and Michigan markets, as established by their IP addresses without using proxy, are eligible to participate in the Promotion.

- If a winning player cannot be contacted successfully (notwithstanding Evolution’s or Participating Operator’s attempts), the prize award may be declared void at Evolution’s discretion, consequent to which the prize shall not be allocated to any other participant. This shall also apply should the prize draw be void through Participating Operator’s negligence such as allowing players from restricted territories to participate or players from Participating Operator’s selectively non-opted in brands of Participating Operator(s) are included in the draw.
- The Prizes:
 - 1000 cash prizes with a total value of 102,600 USD shall be allocated to winning players as follows:

- Any costs related to taxation shall be the player’s responsibility.
- Each Participating Operator with winning player/s shall inform the player of the win and pay the cash prize to the player account.
- Cash prizes allocated to a winning player cannot be subject to ANY additional wagering requirements. A winning player must be able to withdraw their cash prize immediately should they wish to do so.
- Participating Operator must invoice Evolution for the amount of any cash prizes (USD) awarded to winning players in order to be reimbursed for same.

General Terms and Conditions

- A dedicated promo pack for the Promotion will be provided by the Promotions Team/Account Managers on confirmation of operator opt-in.
- Elements of the dedicated promo pack must be used on the gaming site(s), in newsletters and other media, including social media.
- The Eligible Slot Games must be displayed in prominent lobby placements on the gaming site(s).
- Participating Operator must opt-in to the Promotion by August 15, 2024.
- In order to qualify for the prizes, documentation of promotional details/screenshots and refunds must be sent to Participating Operator's dedicated account manager.
- It is the responsibility of the Participating Operator to ensure that the Promotion is conducted in accordance with the applicable laws of the jurisdiction/s in which the Promotion is offered.
- Participating Operator is forbidden to mention and to make references to any copyrighted event's name for any mass marketing/advertising purpose (internet, television, audio, magazine or newspaper).
- Participating Operator is forbidden to use any copyrighted logo(s) or images for any mass marketing/advertising purpose (internet, television, radio, magazine or newspaper).
- The Promotion shall be governed by adequate binding terms and conditions which shall be stipulated by the Participating Operator and agreed by their players prior to permitting such players to participate in the Promotion. Consequently, it is the responsibility of the Participating Operator to receive, respond to and manage, all player queries and complaints in relation to the Promotion and the awarded prize. The Participating Operator understands that Evolution's involvement the Promotion is limited solely to ensuring the prize funds are awarded impartially.
- Participating Operator is obliged to provide a full set of terms and conditions to the players. The Promotion must be socially responsible and

proportionate to players' gambling levels; all promotional play restrictions must be clearly set out, separately from terms relating to bonus abuse; players may not be enrolled in the Promotion without their express and informed consent to accept the relevant terms and conditions; and email, sms and bonus should always have an opt out option; Participating Operator must include a social responsibility message in all marketing (i.e. "please play responsibly").

- Marketing messages concerning the Promotion must include the following language: "If you or someone you know has a gambling problem, help is available. Call 1-800- GAMBLER."
- The Promotion may not be advertised on any responsible gambling website and/or webpages.
- The URL of the responsible gaming official/recognized website and organization must be included in all adverts where it is feasible, practical and necessary to do so. On digital advertising, it should be a minimum of 100px across.
- Every advert must include either a "21+" symbol or "no under 21s" type of message.
- Participating Operator should consider how marketing of the Promotion might affect vulnerable groups and ensure at all times that adverts do not contain content likely to cause harm.
- The Participating Operator undertakes to comply at all times with (a) the relevant terms and conditions of the software license agreement including, but not limited to, marketing provisions; and (b) all applicable laws and regulations as amended from time to time.
- Participating Operator is responsible for all adverts placed by its affiliates and, therefore, is encouraged to use its best endeavors to ensure that all of the relevant legal and regulatory requirements are also followed by its affiliates.
- Participating Operator agrees to waive any and all claims against Evolution relating to the Promotion, save for any willfully fraudulent acts committed by Evolution.
