

# Terms and Conditions

## Promotion Rules and Mechanics

- Red Door White and Blue (the “**Promotion**”) will run from 00:00 EDT on June 25, 2026 until 23:59 EDT on July 5, 2026. (“**Promotion Period**”).
- To participate in the Promotion, Operators must opt-in by completing the online opt-in form made available at <https://promo.evolution.com/red-door-white-and-blue/> (“**Opt-In Link**”) no later than June 11, 2026 (“**Participating Operators**”). By opting in, Participating Operators agree to take part in the Promotion in accordance with these terms and conditions established by Evolution Malta Limited (“**Evolution**”). **The Opt-In Link is intended solely for Participating Operators and must not be shared publicly or included in any player-facing terms and conditions and other materials.**
- **Mechanics:** For each 50 USD wagered by a player on American Red Door Roulette during the Promotion Period, the player will receive 1 entry ticket to a prize draw, with no maximum number of entries. Wager amounts shall be calculated daily to determine the number of entry tickets players receive for each day during the Promotion Period.
- **Participating Operators may not require any further action by the player to “opt in” to the Promotion besides wagering at least 50 USD on American Red Door Roulette during the Promotion Period.**
- Participating Operators must clearly state American Red Door Roulette as the eligible game for the Promotion on Participating Operators’ site(s) and/or app(s).
- American Red Door Roulette must be displayed on each Participating Operator’s home page at all times during the Promotion Period to qualify for the prize draw.
- The prize draw will be held on July 8, 2026.
- Final results of the prize draw will be announced on July 8, 2026.
- 1000 winning players will be selected based on the prize draw. Only players from New Jersey, Pennsylvania, Michigan, Delaware and West Virginia markets, established by their IP addresses without using proxy, playing through Participating Operators who have received approval from the applicable

regulator to run the Promotion where such approval is required, are eligible to participate in the Promotion.

- The Prizes:
  - 1000 prizes totaling 103,250 casino bonus credits<sup>1</sup> subject to a one-time (1x) rollover requirement shall be allocated to winning players as follows:

- \* Participating Operators shall ensure that all awarded casino bonus credits are subject to a one-time (1x) rollover requirement on any casino games before any resulting winnings may be withdrawn.
- Each Participating Operator with winning player(s) shall inform the player(s) of the win and award the casino bonus credits to the player account. If a winning player cannot be contacted successfully, the prize award may be declared void at Evolution’s discretion, consequent to which the prize shall not be allocated to any other participant. This shall also apply should the prize draw be void through Participating Operator’s negligence, such as allowing players from restricted territories to participate or including players from Participating Operator’s selectively non-opted in brands in the draw.
- Any costs related to taxation shall be the player’s responsibility.
- Reimbursements to Participating Operators will be made by Evolution in August 2026.

<sup>1</sup> Casino bonus credits are non-cash promotional credits, with one casino bonus credit equivalent to \$1 USD for wagering purposes only.

## General Terms and Conditions

- A dedicated promo pack for the Promotion will be provided by the Promotions Team/Account Managers on the Promotion opt-in page.
- Elements of the dedicated promo pack must be used on the Participating Operators' gaming site(s) and/or app(s), in newsletters and other media, including social media.
- American Red Door Roulette must be displayed in prominent lobby placements on the Participating Operators' gaming site(s) and/or app(s).
- It is the responsibility of Participating Operators to ensure that the Promotion is conducted in accordance with the applicable laws of the jurisdiction(s) in which the Promotion is offered.
- Participating Operators are forbidden to mention and to make references to any copyrighted event's name for any mass marketing/advertising purpose (internet, television, audio, magazine, or newspaper).
- Participating Operators are forbidden to use any copyrighted logo(s) or image(s) for any mass marketing/advertising purpose (internet, television, radio, magazine, or newspaper).
- The Promotion shall be governed by adequate binding terms and conditions which shall be stipulated by each Participating Operator and agreed to by its players prior to permitting such players to participate in the Promotion. Consequently, it is the responsibility of each Participating Operator to receive, respond to, and manage all player queries and complaints in relation to the Promotion and the awarded prize. Participating Operators understand that Evolution's involvement in the Promotion is limited solely to ensuring the prizes are allocated impartially.
- Participating Operators are obliged to provide a full set of terms and conditions to the players. The Promotion must be socially responsible and proportionate to players' gambling levels; all promotional play restrictions must be clearly set out, separately from terms relating to bonus abuse; players may not be enrolled in the Promotion without their express and informed consent to accept the relevant terms and conditions; and email, sms and bonus should always have an opt out option; Participating Operators must include a social responsibility message in all marketing (i.e. "please play responsibly").

- Marketing messages concerning the Promotion must include the following language: “If you or someone you know has a gambling problem, help is available. Call 1-800- GAMBLER.”
- The Promotion may not be advertised on any responsible gambling websites and/or webpages.
- The URL of the responsible gaming official/recognized website and organization must be included in all adverts where it is feasible, practical and necessary to do so. On digital advertising, it should be a minimum of 100px across.
- Every advert must include either a “21+” symbol or “no under 21” type of message.
- Participating Operators should consider how marketing of the Promotion might affect vulnerable groups and ensure at all times that adverts do not contain content likely to cause harm.
- Participating Operators undertake to comply at all times with (a) the relevant terms and conditions of the software license agreement including, but not limited to, marketing provisions; and (b) all applicable laws and regulations as amended from time to time.
- Participating Operators are responsible for all adverts placed by its affiliates and, therefore, is encouraged to use its best endeavors to ensure that all of the relevant legal and regulatory requirements are also followed by its affiliates.
- Participating Operators agree to waive any and all claims against Evolution and its affiliates, parent companies, subsidiaries, directors, officers, employees, and agents relating to the Promotion, save for any willfully fraudulent acts committed by Evolution.
